The Mayor and the Director of City Planning, on behalf of the City of Pittsburgh, are hereby authorized to provide "funding for matching grants" with the Department of Conservation and Natural Resources and separate project funding for MOVEPGH multimodal transportation system planning, to enter into Agreement or Agreements, or contract, or use existing Agreement(s) or contract(s) with consultant, vendors and/or contractors for the purpose of analyzing and managing the natural systems of the City's Parks and open spaces of the City of Pittsburgh at a cost not to exceed \$100,000.00, and planning for increased accessibility to those lands within a multimodal transportation system, at a cost not to exceed \$200,000.00 chargeable to and payable from the following accounts:
