Dear Members of City Council:

Attached is a proposed Resolution authorizing the Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, to enter into a supplemental agreement or agreements with A. Liberoni Inc., for costs associated with Construction for the Sylvan Avenue Multimodal Path Project; providing for the payment of the costs thereof, not to exceed One Million Eight Hundred Seventy-One Thousand Eight Hundred Ten Dollars and Ninety-Seven Cents (\$1,871,810.97) a net increase of One Hundred Thirty-Nine Thousand Three Hundred Six Dollars and Eighty-Four Cents (\$139,306.84) from the previously authorized agreement, reimbursable at various rates.

A waiver of Rule 8 is requested to expedite amending the contract in an effort to move the Sylvan Avenue SMART project through the closeout process as soon as possible.

Your favorable consideration of the attached proposed Resolution is hereby requested.
