Dear Members of City Council:

Enclosed is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pittsburgh Water and Sewer Authority (PWSA) for costs associated with the Ruthven Street Retaining Wall project; providing for payment of costs thereof, not to exceed a total of One Million Two Hundred Twenty-Five Thousand Seven Hundred Sixty-Five Dollars and Twenty-Four Cents (\$1,225,765.24), an increase of Two Hundred Ninety-Five Thousand Three Hundred Twenty-Eight Dollars and Twenty-Four Cents (\$295,328.24) from the previously executed agreement, where PWSA would be responsible for paying 100% of the actual expenses involved in certain work to be described in the Agreement(s), at no cost to the City of Pittsburgh.
