Dear Members of City Council:

Attached is a proposed Resolution authorizing the Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, to enter into a supplemental agreement or agreements with MS Consultants, Inc. for costs associated with the Preliminary Engineering and Final Design phases of the California Avenue Bridge project; providing for the payment of the costs thereof, not to exceed Two Million Two Hundred Five Thousand Six Hundred Ninety-Two Dollars and Ninety-Six Cents (\$2,205,692.96), an increase of One Million Three Hundred Sixty Thousand Eight Hundred Ninety-Six Dollars and Ninety-Five Cents (\$1,360,896.95) from the previously authorized agreement, reimbursable at 100%.
