[2007-1740](#) Article III, Sewers, Chapter 433, Illegal Stormwater Connections, in order to include federal and state-mandated prohibitions regarding the drainage or conveyance, whether on the surface or subsurface, of non-storm water discharge from real property including sewage, process wastewater, and wash water into the Waters of the Commonwealth, and to add a definition of "Sale" exempting sales of real property pursuant to the Second Class City Treasurer's Sale and Collection Act, 53 P.S. § 27101 et seq., as amended, from the requirements of the ordinance with regard to sales of real property.
