**RE: Larimer Ave Bridge Reimbursement  
Agreement Amendment**

Dear Members of City Council:

Attached is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Preliminary Engineering, Final Design, and Right-of-Way phases of the Larimer Ave Bridge Project; providing for the payment of the costs thereof, not to exceed Three Million Seven Hundred Thousand Dollars (\$3,700,000.00), an increase of Two Million One Hundred Thousand Dollars (\$2,100,000.00) from the previously executed agreement. This resolution serves to authorize only the amended Reimbursement Agreement or Agreements, at a cost of Four Thousand Five Hundred Dollars (\$4,500.00), an increase of Three Thousand Dollars (\$3,000.00) from the previously executed agreement, to the City of Pittsburgh. Future Resolutions will authorize the project specific service agreements.
