Enterprises, Inc. for costs associated with the North Avenue Reconstruction Project, and providing for the payment of costs thereof, not to exceed Four Million Nine Hundred Forty-One Thousand Five Dollars and One Cent (\$4,941,005.01), of which Two Million Eight Hundred Eighty Thousand Dollars (\$2,880,000.00) are reimbursable.

A waiver of Rule 8 is requested to expedite entering into this agreement with C.H. & D. Enterprises, Inc. in an effort to move North Avenue Reconstruction Project into the construction phase as soon as possible.
