**RE: Swindell Bridge Reimbursement  
Agreement, Second Amendment**

Dear Members of City Council:

Attached is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Preliminary Design, Final Design, and Right of Way phases of the Swindell Bridge construction project, and providing for the payment of municipal incurred costs thereof, not to exceed Three Million Eight Hundred Thousand Dollars (\$3,800,000.00), an increase of Two Million One Hundred Thousand Dollars (\$2,100,000.00) from the previously executed agreement (54006.1); reimbursable at ninety five percent; and the municipal share of Commonwealth Incurred Costs not to exceed Seven Thousand Dollars (\$7,000.00), a Five Thousand Five Hundred Dollar (\$5,500.00) increase from the previously executed agreement (54006.1).
