**RE: West Carson Street Bridge
Reimbursement Agreement Amendment**

Dear Members of City Council:

Attached is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Preliminary Engineering, Final Design, and Right-of-Way phases of the West Carson Street Bridge Project; providing for the payment of the costs thereof, not to exceed Two Million One Hundred Fifty Thousand Dollars (\$2,150,000.00), an increase of One Million Two Hundred Fifty Thousand Dollars (\$1,250,000.00) from the previously executed agreement. This resolution serves to authorize only the amended Reimbursement Agreement or Agreements, at a cost of Three Thousand Two Hundred Fifty Dollars (\$3,250.00), an increase of One Thousand Seven Hundred Fifty Dollars (\$1,750.00) from the previously executed agreement, to the City of Pittsburgh. Future Resolutions will authorize the project specific service agreements.
