RE: Liberty Ave HSIP Right of Way

Dear Members of City Council:

Attached is a proposed Resolution authorizing the Director of the Department of Finance and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, to enter into certain temporary construction easements and permanent right-of-way acquisitions on certain properties in the 2nd and 6th Ward of the City in order to advance the Liberty Avenue Highway Safety Improvement Program (HSIP). Costs for these temporary construction easements shall not exceed Six Hundred Ninety Thousand Dollars (\$690,000.00), reimbursable at 90% for the first \$90,000.00 as set forth under Legislation 600 of 2023, and reimbursable at 80% for the remaining \$600,000.00 as set forth in Legislation 215 of 2025.
