**RE: Smithfield St Reconstruction  
Agreement, Sixth Amendment**


Dear Members of City Council:

Attached is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Preliminary Design, Final Design, Right-of-Way, and Construction phases of the Smithfield Street Reconstruction project, and providing for the payment of costs thereof, not to exceed Ten Million One Hundred Twenty-Six Thousand Dollars (\$10,126,000.00) an increase of Two Hundred Thirty-Six Thousand Dollars (\$236,000.00) from the previous resolution, reimbursable at eighty percent; and the municipal share of Commonwealth Incurred Costs not to exceed Forty-Five Thousand Dollars (\$45,000.00), a Zero Dollar (\$0.00) increase from the previous resolution (72 of 2026).

A waiver of Rule 8 is requested to expedite entering into this agreement with Pennsylvania Department of Transportation in an effort to move the Smithfield Street Reconstruction project into the construction phase as soon as possible.

Your favorable consideration of the attached proposed Resolution is hereby requested.
