Test drove machine noticed right track had no power.
Swapped pilot hoses from control valve to pump servos to check for control valve problem (OK)
Swapped hoses from left ground drive pump to right ground drive pump to qualify right ground drive motor (OK)
Front section of ground drive pump has failed.
Pulled filter its full of metal from pump failure.

CHECK OVER:

Gas shock on rear cover is missing
Needs track tension adjustment

Recommend:

- Replacing ground drive pump
Replacing hydraulic filter
hydraulic system flush (104 QTS HYDRAULIC OIL)
Replacing gas shock on rear cover
