**RE: Liberty Ave HSIP Sixth Supplement to
Reimbursement Agreement**

Dear Members of City Council:

Attached is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Preliminary Design, Final Design, Right of Way, and Construction phases of the Liberty Ave Highway Safety Improvements Program (HSIP); providing for the payment of the costs thereof, not to exceed Fourteen Million Eight Hundred Eighty-Three Thousand One Hundred Fifty-One Dollars and Ninety-Three Cents (\$14,883,151.93) an increase of One Million Nine Hundred Seventy-Seven Thousand Five Hundred Ninety-Five Dollars and Ninety-Three Cents (\$1,977,595.93) from the previously authorized amount, reimbursable at eighty percent; and the municipal share of Commonwealth Incurred Costs not to exceed Twenty-Nine Thousand Seven Hundred Dollars (\$29,700.00), an increase of Zero Dollars (\$0.00) from the previously authorized amount (215 of 2025). Future Resolutions will authorize the project specific agreements.
