**RE: TA Set-Aside - Safe Routes to School
Reimbursement Agreement Amendment**

Dear Members of City Council:

Attached is a proposed Resolution amending Resolution 127 of 2023 providing for a Reimbursement Agreement or Agreements between the City of Pittsburgh (City) and Commonwealth of Pennsylvania (PennDOT) in connection with PennDOT's Transportation Alternatives Set-Aside (TA Set-Aside) and the City's Safe Routes to School (SRTS) program for costs associated with the Preliminary Engineering and Construction phases of the project; providing for the payment costs thereof, not to exceed Three Hundred Forty-Five Thousand (\$345,000.00) Dollars, an increase of Two Hundred Twenty Thousand Dollars (\$220,000.00) from the previously executed agreement for costs associated with the Preliminary Engineering phase of the project, federally reimbursable at one hundred percent; and the municipal share of Commonwealth Incurred Costs not to exceed Zero dollars (\$0.00).
