Date: July 13, 2022

Pursuant to the enclosed, the Special Election in Pittsburgh Council District #5 will be held on Tuesday, November 8, 2022.

The qualified political parties, i.e., Democratic and Republican, are entitled to nominate one candidate each by means of nomination certificate pursuant to their respective party rules. The Chairs of these parties will be mailed all the necessary filing documents under separate cover.

Independent (political body) candidates are required to file nomination papers containing the signatures of at least 166 registered electors (regardless of party affiliation), in order to have their name printed on the ballot. The filing fee is \$50.00.

Since this Special Election coincides with the regularly scheduled, November 8, 2022 General Election, all cost associated are the responsibility of the county.

WRIT OF ELECTION

TO THE ALLEGHENY COUNTY BOARD OF ELECTIONS OF THE
COMMONWEALTH OF PENNSYLVANIA:

WHEREAS, in consequence of the resignation of the Honorable Corey O'Connor, who was elected a Member of the City Council of the City of Pittsburgh, Pennsylvania, a vacancy exists in the representation of the Fifth City Council District of the City of Pittsburgh.

NOW, THEREFORE, I, Brenda F. Pree, City Clerk of the City of Pittsburgh, in pursuance of the provisions of the Constitution of the United States, the Act of General Assembly in the Commonwealth of Pennsylvania, entitled, "The Pennsylvania Election Code," approved the third day of June, in the year of Our Lord, One Thousand Nine Hundred and Thirty-Seven, as amended, and the Home Rule Charter of the City of Pittsburgh, have issued this Writ, commanding you to do your respective duties according to law, to hold an election in the Fifth Council District of the City of Pittsburgh on:

TUESDAY, THE EIGHTH DAY OF NOVEMBER, IN THE YEAR OF OUR LORD, TWO THOUSAND TWENTY-TWO for the election of a Member of City Council to represent the Fifth Council District of the City of Pittsburgh to fill the vacancy aforesaid, for the unexpired term of the Honorable Corey O'Connor; and you are hereby required and enjoined to give lawful notice of said election, and make return thereof in manner form as by law is directed and required.
