Dear Members of City Council:

Enclosed is a proposed resolution providing for an amended Reimbursement Agreement or Agreements with Pittsburgh Water for costs associated with the RAISE Grant project where Pittsburgh Water would be responsible for paying 100% of the actual expenses involved in certain work to be described in the Agreement(s), at an amount not to exceed One Hundred Thousand Dollars (\$100,000.00), an increase of Fifty Thousand Dollars (\$50,000.00) from the previously executed agreement, and further amending Resolution 834 of 2025, effective December 21, 2025, entitled "Resolution adopting and approving the 2026 Capital Budget, the proposed 2026 Community Development Program, and the 2026 through 2031 Capital Improvement Program" by increasing RAISE Grant project (TIP) by Fifty Thousand Dollars (\$50,000.00).
