Local Governance”, by prohibiting the discrimination on the basis of race, religion, ancestry, sex, sexual orientation, age, gender identity or expression, disability, place of birth, national origin or association or affiliation with any nation or foreign state in conducting business of the city”?

“Shall the Pittsburgh Home Rule Charter be amended and supplemented by adding a new Article 11: RIGHT TO PUBLIC OWNERSHIP OF POTABLE WATER SYSTEMS, WASTEWATER SYSTEM, AND STORM SEWER SYSTEMS, which restricts the lease and/or sale of the City’s water and sewer system to private entities?”


