**RE: North Avenue Signals and Safety
Reimbursement Agreement Amendment**

Dear Members of City Council:

Attached is a proposed Resolution amending Resolution 191 of 2024, providing for a Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Construction phase of the North Avenue Signals and Safety Project, and providing for the payment of costs thereof, not to exceed Three Million Six Hundred Thousand Dollars (\$3,600,000.00), an increase of One Million One Hundred Thousand Dollars (\$1,100,000.00) from the previously executed agreement, reimbursable at eighty percent; and the municipal share at a cost to the City of Pittsburgh not to exceed Twenty Thousand Dollars (\$20,000.00).

A waiver of Rule 8 is requested to expedite entering into this agreement with Pennsylvania Department of Transportation in an effort to move the North Avenue Signals and Safety project into the Construction phase as soon as possible.

Your favorable consideration of the attached proposed Resolution is hereby requested.
