
**RE: Liberty Ave HSIP Third Supplement to Reimbursement Agreement**

Dear Members of City Council:

Enclosed is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with multiple phases of the Liberty Ave Highway Safety Improvements Program (HSIP); providing for the payment of the costs thereof, not to exceed Seven Million Five Hundred Five Thousand Five Hundred and Fifty Six Dollars (\$7,505,556.00), an increase of One Hundred Thousand Dollars (\$100,000.00) for the Right of Way phase from the previously executed agreement (52315-2). This resolution serves to authorize only the Reimbursement Agreement, at a cost to the City of Pittsburgh of Five Thousand Five Hundred Dollars (\$5,500.00), an increase of One Thousand Dollars (\$1,000.00) from the previously executed agreement (52315-2). Future Resolutions will authorize the project specific service agreements.

Your favorable consideration of the attached proposed Resolution is hereby requested.
