(PTSI; see Act 121 of 2024) will further challenge the city's contracted workers' compensation attorneys and strategies are being developed to protect the best interests of the City; consistency in our representation is integral to navigating this impactful bill.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Carahsoft OBO City of Pittsburgh (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
