**RE: Penn Ave Phase 2 Right of Way**

Dear Members of City Council:

Attached is a proposed Resolution authorizing the Director of the Department of Finance and the Director of the Department of Mobility and Infrastructure, on behalf of the City of Pittsburgh, to enter into certain temporary construction easements on certain properties in the 8<sup>th</sup> and 10th Ward of the City in order to advance the Penn Avenue Reconstruction Phase 2 Project. Costs for these temporary construction easements shall not exceed Twenty Thousand Dollars (\$20,000.00), reimbursable at 80%.

A waiver of Rule 8 is requested to expedite this authorization so the city can begin contracting the temporary construction easements with the property owners as soon as possible – so that we don't delay the project waiting to secure these easements
