- 1. Hillcrest Street Green Infrastructure Project** **ROW AND VACANT LOTS**
Located near the intersections of North Atlantic Avenue and Hillcrest Street, in the neighborhood of Garfield, in **Council District 9**, in the 10th Ward of the City of Pittsburgh, the project area includes improvements both in the public right of way and on two City of Pittsburgh properties: Lot and Block Number 50-G-148 and 50-G-142.
- 2. Wightman Green Infrastructure Project** **ROW AND PARK**
Located near the intersection of Wightman Street and Solway Street, in the neighborhood of Squirrel Hill, in **Council District 8**, in the 14th Ward of the City of Pittsburgh, the project area includes improvements both in the public right of way and on City of Pittsburgh property: Lot and Block Number 85-P-53.
- 3. Hayson Avenue Green Infrastructure Project** **ROW**
Located near the intersection of Red Oak Drive and Hayson Avenue, in the neighborhood of Banksville, in **Council District 2**, in the 20th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way.
- 4. Centre and Herron Green Infrastructure Project** **ROW AND VACANT LOT**
Located near the intersection of Centre Avenue and Herron Avenue, in the neighborhood of Upper Hill District, in **Council District 6**, in the 5th Ward of the City of Pittsburgh, the project area includes improvements both in the public right of way and on City of Pittsburgh property: Lot and Block Number 27-J-501.
- 5. Melwood and Finland Street Green Infrastructure Project** **ROW**
Located near the intersection of Melwood Avenue and Finland Street, in the neighborhood of Polish Hill, in **Council District [2] 7**, in the [20th] **6th** Ward of the City of Pittsburgh, the project area includes improvements in the public right of way.
- 6. McKinley Park Green Infrastructure Project** **ROW AND PARK**
Located near the intersection of Michigan Street and Delmont Avenue, in the neighborhood of Beltzhoover, in **Council District 3** and Council District 4, in the 18th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way and on City of Pittsburgh property: Lot and Block Number 34-D-20.
- 7. South 21st Street Green Infrastructure Project** **ROW**
Located on South 21st Street between Josephine Street and East Carson Street, in the neighborhood of Southside Flats, in **Council District 3**, in the 16th Ward and 17th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way.
- 8. MLK Field Green Infrastructure Project** **ROW AND PARK**
Located near the intersection of Bentley Drive and Kirkpatrick Street and within the Martin Luther King Jr./Warren K. Branch Park, in the neighborhood of Terrace Village, in **Council District 6**, in the 5th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way and on City of Pittsburgh Property: Lot and Block Number 11-C-1.
- 9. Thomas and McPherson Green Infrastructure Project** **ROW**
Located near the intersection of Thomas Boulevard and N Linden Avenue, in the neighborhood of Point Breeze North, in **Council District 9**, in the 14th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way.
- 10. Lawn and Ophelia Green Infrastructure Project** **ROW AND PARK**

Located near the intersection of Lawn Street and Ophelia Street, in the neighborhood of South Oakland, in **Council District 6**, in the 20th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way and on City of Pittsburgh property: Lot and Block Number 28-N-110.

11. Maryland Avenue Green Infrastructure Project

ROW

Located near the intersection of Howe Street and Maryland Avenue, in the neighborhood of Shadyside, in **Council District 8**, in the 7th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way.

12. Woods Run Stream Inflow Project

ROW AND VACANT LOT

Located within Riverview Park, in the neighborhood of Perry North, in **Council District 1**, in the 26th Ward of the City of Pittsburgh, the project area includes improvements in the public right of way and on City of Pittsburgh property: Lot and Block Number 76-D-1-0-2.
