**RE: Charles Anderson Bridge
Reimbursement Agreement Amendment**

Dear Members of City Council:

Attached is a proposed Resolution providing for an amended Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for the Charles Anderson Bridge project; providing for the payment of the costs thereof, not to exceed Fifty-Nine Million Eight Hundred Ninety Thousand Dollars (\$59,890,000.00), an increase of Fifty-Six Million Two Hundred Thousand Dollars (\$56,200,000.00) from the previously executed agreement for costs associated with the Construction phase of the project. This resolution serves to authorize only the amended Reimbursement Agreement, at no cost to the City of Pittsburgh. Future Resolutions will authorize the project specific service agreements.

A waiver of Rule 8 is requested to expedite entering into this agreement with Pennsylvania Department of Transportation in an effort to move the Charles Anderson Bridge project into the construction phase as soon as possible.
