**RE: Safe Routes to School  
Reimbursement Agreement**


Dear Members of City Council:

Attached is a proposed Resolution providing for a Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Preliminary Design and Construction phases of the Safe Routes to School (SRTS) program and providing for the reimbursement of municipal incurred costs thereof, not to exceed Four Hundred Twenty Thousand Dollars (\$420,000.00), an increase of Seventy-Five Thousand Dollars (\$75,000.00) from the previously executed agreement, federally reimbursable at One Hundred percent; and the municipal share of Commonwealth Incurred Costs not to exceed Zero dollars (\$0.00).

A waiver of Rule 8 is requested to expedite entering into this agreement with Pennsylvania Department of Transportation in an effort to move the Safe Routes to School project into the Preliminary Design and Construction phases as soon as possible.

Your favorable consideration of the attached proposed Resolution is hereby requested.
