

The above parcels contain a total of approximately 51,696 square feet with a purchase price of \$1.00 plus costs. Two of the parcels (Block 3-R, Lots 305 and 306) are improved with vacant structures; the remaining parcels are vacant land. The URA would like to acquire these properties for conveyance to Hilltop Alliance and/or Gatesburg Road Development, or an entity to be formed, for a scattered site affordable residential development.
