## First Amendment to Administrative Services Agreement

This First Amendment ("First Amendment") to that certain Administrative Services Agreement (the "Agreement"), with an Effective Date of January 1, 2020, is made and entered into by and between CONNECTYOURCARE, LLC, ("CYC") and CITY OF PITTSBURGH ("Employer"). Each of CYC and Employer is a "Party", and collectively, the "Parties". Except as expressly provided herein, all other terms and conditions as set forth in the Agreement shall remain in full force and effect and shall continue to be binding on the Parties hereto. Solely to the extent that the terms of the First Amendment conflict with any terms of the Agreement, this First Amendment supersedes the Agreement. Otherwise, this First Amendment is governed by and subject to the terms of the Agreement.

## RECITALS

- 1. WHEREAS, Employer and CYC entered into an Administrative Services Agreement with an Effective Date of January 1, 2020; and
- 2. WHEREAS, pursuant to Section 10 of the Agreement, the Parties desire to amend the Agreement and Exhibits attached thereto; and
- 3. WHEREAS, capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Agreement.

## AGREEMENT

NOW, THEREFORE, in consideration of the foregoing and mutual warranties, representations, covenants, and agreements contained in this First Amendment, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. <u>Term.</u> Section 8(a) of the Agreement is hereby deleted in its entirety and replaced with the following language:
  - a) Term. The term of this Agreement shall commence on the Effective Date and continue until December 31, 2023 (the "Initial Term"). After the Initial Term, this Agreement shall automatically extend for additional periods of one (1) years each (a "Renewal Term") unless either Party gives the required written notice of termination, with or without cause, at least ninety (90) days prior to the end of the then-current term. CYC shall guarantee the rates stated in the attached fee schedule for three (3) years following the Effective Date.
- 2. Except as set forth in this First Amendment, the Agreement is unaffected and shall continue in full force and effect in accordance with its terms.
