**RE: Pittsburgh Pedestrian Wayfinding Reimbursement Agreement
Amendment**

Dear Members of City Council:

Enclosed is a proposed Resolution providing for an amendment Reimbursement Agreement or Agreements with the Pennsylvania Department of Transportation for costs associated with the Construction phase of the Pittsburgh Pedestrian Wayfinding Project; providing for the payment of the costs thereof, not to exceed Two Million Dollars (\$2,000,000.00), an increase of Five Hundred Thousand Dollars (\$500,000.00) from the previously executed agreement. This resolution serves to authorize only the amended Reimbursement Agreement or Agreements, at no cost to the City of Pittsburgh. Future Resolutions will authorize the project-specific service agreements.

A waiver of Rule 8 is requested to expedite entering into this agreement with the Pennsylvania Department of Transportation as they have already bid this project out and this agreement is needed so that construction can be awarded as soon as possible.

Your favorable consideration of the attached proposed Resolution is hereby requested.
