Resolution Number 858 of 2014

Resolution adopting and approving the 2015 Capital Budget and the 2015 Community Development Block Grant Program; and approving the 2015 through 2020 Capital Improvement Program.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The 2015 Capital Budget and the 2015 Community Development Block Grant Program is hereby adopted and the new project authorizations and Community Development Block Grant Program categories listed therein are hereby approved.

Section 2. The 2015 through 2020 Capital Improvement Program is hereby approved as a guide, but new project authorizations are made subject to approval by Council through adoption of the annual Capital Budget and Community Development Block Grant Program.

Section 3. The City Controller, the City Treasurer, and the Capital Budget Manager are hereby authorized to place in the Bond Fund all cash currently on hand from the proceeds of the sale of debt and to accept reimbursement to such fund from other sources for expenditures made under Federal, State or private grant programs.

Section 4. The City Controller, the City Treasurer, and the Capital Budget Manager are hereby authorized to transfer from the Bond Fund to the Sinking Fund such funds as may be received as reimbursement for Capital Projects for which Bond Anticipation Notes have been specifically sold in previous years to fund such reimbursable projects.

Section 5. The City Controller, the City Treasurer, and the Capital Budget Manager are hereby authorized to place in the Capital Fund all cash currently on hand from the transfer of funds from the City's Fund Balance to the Capital Budget, and the accept reimbursements to such fund from other sources for expenditures made under Federal, State, or private grant programs. Such transfer shall be made by separate legislation.

Section 6. In accordance with Ordinance 694 of 1990 all cost projections will be made at the time each project is bid.

Introduction



The 2015 Capital Improvement Plan

This document is the 2015 Capital Improvement Plan (CIP) as passed by City Council. It contains a list of capital projects, along with funding levels for each of these projects.

What is a Capital Project?

Title II, Chapter 218 of the City Code defines a capital project as: "Any project funded by public monies, or proposed to be funded by public monies, to build, restore, retain, or purchase any equipment, property, facilities, programs or other items, including buildings, park facilities, infrastructure, information technology systems, or other equipment, that is funded on a necessarily non-repeating, or non-indefinite, basis and that is to be used as a public asset, or for the public benefit. Any and all funds used for a Capital Project shall be used in accordance with the rules and regulations of the fund source. Capital projects shall have a minimum value of fifty thousand dollars (\$50,000.00)."

While capital projects are not maintenance, they do include renovation and major repair or reconstruction of damaged and deteriorating city-owned facilities.

Source of Funds


PAYGO: The City funds a number of capital projects through a transfer from the general fund into the capital fund. PAYGO transfers (or "pay-as-you-go") are funds that the city then spends on capital projects. In the 2015 Capital Improvement Plan, projects funded with PAYGO are mainly focused on neighborhood improvement, economic development, and blight remediation.

Bond: Because Capital projects have a useful life extending beyond a few years, the City may incur debt, in the form of municipal bonds, in order to complete capital projects. Incurring debt is done for two reasons. The first is that debt is an instrument to spread the cost of a project over all of the citizens who will benefit from the project: not just current citizens, but future ones as well. The second is the City does not have the funds on hand to complete the majority of projects from its own sources. Therefore, projects funded with debt proceeds should be long-lasting because we will be paying for the life of the debt.

CDBG: The City receives support for capital projects from the federal government in the form of the Community Development Block Grant (known as "CDBG"). As a block grant, the CDBG program gives the City some flexibility on how to spend the money, provided the projects funded benefit low- and moderate-income people, eliminate blight, or address a threat to health or safety.

OTHER: The City uses numerous other sources to pay for capital projects. Some projects are fully or partially funded through grants from other governmental authorities, the Commonwealth of Pennsylvania or the federal government. Others are supported by foundations and non-profits. A portion of the cost of large transportation improvement projects (also known as "TIP") is typically reimbursed by the state and federal government.

The Capital Budgeting Process

The capital budgeting process begins with the first meeting of the Capital Program Facilitation Committee (CPFC). This committee was created to increase transparency in the capital process and includes representatives of the Mayor, City Council, the City Controller, and City Departments.

In April, the Mayor submits to all departments a list of priorities for the Capital Improvement Plan. The Mayor's priorities centered around four key areas in 2015:

- Public Safety
- Neighborhood and Community Development
- Infrastructure Improvements
- Innovation and Performance

Shortly thereafter, the Office of Management and Budget requests capital project proposals from departments, City Council, and the Urban Redevelopment Authority and compiles them for the CPFC.

The CPFC reviews project proposals and ranks them based on how well they meet the following criteria:

- 1. Resolve an imminent threat to public or employee safety or health
- 2. Achieve compliance with federal or state statutory mandates
- 3. Comply with the City's Comprehensive Plan
- 4. Allow for cooperative purchasing with other governments
- 5. Reduce impact on the City's operating budget
- 6. Improve efficiency or effectiveness of service delivery
- 7. Improve quality of life in all City neighborhoods
- 8. Demonstrate support of the public

The Mayor receives a copy of the recommendations of the CPFC. The CPFC also holds two public meetings to gather testimony from the public in support of various capital projects.

The Mayor proposes a Capital Improvement Plan using the rankings of the CPFC and the administration's priorities, which is then introduced as legislation for discussion in City Council.

City Council then reviews the proposed budget, holds public meetings, deliberates, and proposes amendments to the budget. A final budget (this document) is passed by Council and signed by the mayor before December 31st.

The Six Year Capital Improvement Plan

Because the capital needs of the City surpass the available funding of any given year, it is critical that the City budget for more than just the present year. The six year capital improvement plan is a way for the city to prioritize what projects are funded in the present year, and estimate the resources that will be needed in the future. In addition to noting the projects that were funded last year, the six year Capital Improvement plan includes information about the current year (2015) and provides an estimate of the funding level a project will require for the five years following (2016-2020).

Functional Areas

Projects in the Capital Improvement Plan are grouped by their functional area. Some projects may involve more than one department, although all projects have one department serving as the project lead.

Engineering and Construction: These projects are improvements to the walls, steps, fences, roads, sidewalks, and bridges throughout the City of Pittsburgh. They also include large highway and bridge projects, street resurfacing, as well as projects to make our streets safer for pedestrians and cyclists.

Facility Improvements: These projects are major repairs or rehabilitation of City-owned facilities, such as parks, playgrounds, pools, ballfields, and buildings.


Public Safety: These projects repair and replace important infrastructure for the health and well-being of City residents, and eliminate public safety risks.

Vehicles and Equipment: These projects involve the purchasing of vehicles and heavy equipment for public safety and service-delivery.

Neighborhood Development: These projects are investments in our City's neighborhood business districts, residential communities, and small businesses that raise the quality of life for residents.

Administration and Pass-Through: These projects are distinct from the other functional areas in that they are typically pass-through grants dispersed to various non-profits and community-based organizations. Other projects include costs associated with the administration of the City's Capital Improvement Plan and City-owned assets.

How to read the Capital Improvement Plan

For each project, the Capital Improvement Plan will show the following information:

- A project name, functional area, responsible department, and project manager
- A capital improvement schedule- a chart showing the prior year funding level (if any), proposed funding level for 2015, and projected funding for the following five years.
- **Project description** a brief description of the project.
- Project justification- a section describing why the project is necessary for the good of the city.
- **Operating Budget Impact** a section describing the effect the implementation of the project will have on the present and future operating budgets.
- **Unexpended prior year funds-** amount of money remaining for the project from prior years, as of November 30, 2014.
- **2015 Deliverables** a list of tentative improvements to be made using the project funds, location, the expected duration of work, and the approximate share of the total project cost. The goal of this section is to begin the process of formally prioritizing capital needs in the

City, while understanding and appreciating the need for flexibility throughout the year. <u>The outcomes and deliverables are tentative and may change throughout the year as new needs, priorities, and emergencies arise.</u>

• **Location-** a map showing the tentative locations of the project within the City of Pittsburgh.

Potential Changes to the Capital Budget Ordinance

The administration is in the process of proposing changes to the capital budget ordinance, chapter 218. The goal of these changes is twofold: first to increase the opportunity for public participation in the budgeting process, and second to insure that capital expenditures are going to long-lasting projects that provide public benefit. In anticipation of potential changes to the ordinance, the 2015 capital improvement plan will also identify "project types" for each project, using the following definitions:

- Capital Project- Any project funded by public monies to design, build, restore, retain, or
 purchase any City-owned asset that is expected to provide a long-term public benefit or
 propose physical improvements in an element of the City's infrastructure. Capital Projects shall
 have a minimum value of fifty thousand dollars (\$50,000) and a minimum useful life of five
 years. Capital Projects financed through debt should have a minimum useful life no shorter
 than the length of debt service.
- **Special Revenue Project** A project funded by public monies granted to the city by an outside funding source, including grants and the Community Development Block Grant. Special revenue projects must adhere to the rules and regulations regarding the use of funds promulgated by the funding source.
- Intergovernmental Project- A project that supports the mission of an authority or government
 entity through the allocation of city funding or special revenues. Intergovernmental projects
 must be consistent both with the rules and regulations of the funding source, and the policies
 of the authority, or government entity with whom the project is undertaken.

Accountable Capital Budgeting

This Capital Improvement Plan maintains a commitment to openness and transparency in the budgeting process. As much as possible, this CIP aims to set us on the path to accountable capital budgeting, modeled on some of the best practices in capital budgeting nationally. By providing information such as a project justification and operating impact, we are moving toward better strategic planning and assessing the true cost of capital projects.

One of the significant changes to the 2015 Capital Improvement Plan over previous years is the relocation of approximately \$2.2 million in projects previously included in the Capital Budget that are more appropriately funded in the Operating Budget. These expenses include small equipment purchases, technology leases, and other short-lived expenses. The Mayor's Office of Management and Budget and the Council Budget Office will continue this process moving forward, so that the Capital Improvement Plan represents truly long-lasting improvements to the City of Pittsburgh.

Project Description

This project is a replacement of the 28th Street Bridge, originally constructed in 1931 on the site of a previous bridge, which connects the Strip and the neighborhood of Polish Hill. The bridge carries 28th Street between Liberty Avenue and Brereton street, a total length of 315 feet.

Project Justification

The project is on the regional TIP. This provides an 80% match of Federal Highway Administration funds to the City's 20% match. Since such a large share of the cost is borne by non-city entities, TIP projects are high priorities.

Operating Budget Impact

This project represents minimal operating expense other than the time of Engineering staff. A new bridge should realize some operational maintenance savings.



Installation of new equipment will require a commitment of staff time, but will result in lower maintenance requirements in future years.








