

Resolution amending a number of Community Development Block Grant (CDBG) authorization

resolutions to reflect the change of the Community Development Division from the Department of City Planning to the Office of Management and Budget.

#### Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** Resolution number 348 of 2016 is hereby amended at Section 1 as follows, to reflect the move of the Community Development Division from the Department of City Planning to the Office of Management and Budget:

Section 1. The Mayor and the Director of [City Planning] the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement/Agreements and Contract/Contracts in form approved by the City Solicitor, with the Consultant(s) and Vendor(s) for the purpose of assisting the City in preparing and implementing a two-way communication process for the purpose of citizen involvement in planning, implementing and evaluating City programs and projects including, but not limited to the Five-Year Development Program, the Consolidated Plan, and for providing planning and architectural assistance, at a cost not to exceed \$200,000.00, chargeable and payable from the following account:

**Section 2.** Resolution number 667 of 2016 is hereby amended at Section 1 as follows, to reflect the move of the Community Development Division from the Department of City Planning to the Office of Management and Budget:
