Authorization is requested for Commission Representatives Rita Porterfield and Chris Soult, as well as our housing solicitor Jeffrey Ruder, to attend the John Marshall Law School Fair Housing Training Conference from September 4-6, 2019. The U.S. Department of Housing and Urban Development (HUD) recommends this training for all fair housing assistance program (FHAP) staff. The Pittsburgh Commission on Human Relations is currently the only FHAP in Pennsylvania. The staff to attend are new to the Commission and have not received this formal fair housing training. The solicitor is to participate in updated trainings, and has not received updated fair housing training since 2017.
