

# 2021 Neighborhood Economic Development Grant Process Report

This document summarizes the 2021 Neighborhood Economic Development (NED) application process. The NED grant program (formerly ACCBO), provides \$500,000 of CDBG funds toward community based organizations providing economic development in City neighborhoods. Office of Management and Budget's Community Development Division administers this grant according to HUD and City regulations. This document accompanies the 2021 NED Advisory Committee recommendations in the attached legislation and provides context for the decision-making process.

# 2021 Program Updates

The Community Development Division incorporated suggestions collected through interviews with NED Advisory Committee members, and meetings with the Mayor's Office and City Council to improve the NED 2021 process and address equity and advisory committee participation. The most significant change has been to award one \$50,000 capacity building grant for four years for organizations spending less than \$200,000 annually on staff. The objective is to provide an opportunity for smaller organizations to access this important funding. See the Program Updates Memo in Appendix A for more information.

# **Application Process**

Applicants seeking NED funding had to submit an application with their most recent IRS 990 tax form and current operating budget. There was one 2021 NED application for applicants seeking regular NED funding and/or NED Capacity Building funding, with one question only Capacity Building applicants needed to submit. Applicants determined to have NED eligible projects based on defined eligibility criteria were invited to present to the NED Advisory Committee for 45 minutes, consisting of 30 minutes for a slideshow presentation and 15 min for questions from NED Advisory Committee. All applicants seeking Capacity Building funds were also considered for regular NED as well. See 2021 NED Application in Appendix B.

#### Outreach

The NED grant application opened on April 5. We emailed 450 people through our contact list which consists primarily of previous grant applicants and contacts from the Office of Community Affairs. We also advertised in the Pittsburgh Post-Gazette and Pittsburgh Courier, as well as the Office of Community Affairs' April newsletter and on the City's Homepage.

To make sure applicants were aware of changes to the NED program, we held a webinar on April 16, 2021 to provide an overview of the Regular and Capacity Building NED grants. Also, we had two open office hours April 23 and April 30, 2021 for applicants to ask about their specific project. See the 2021 NED Schedule in Appendix C for full timeline of grant.

# **Applicants**

By the grant deadline on May 14, 2021, we received 29 applications requesting \$1,331,500 in NED funding. Twelve of the applicants applied for the Capacity Building funds.

#### Score Criteria

Scoring criteria has changed from last year. There is a 90 point scale to score applicants. Committee members agreed to score 30 points of each proposal according to the demonstrated need of the application's proposed service area. Those 30 points were based on demographic data representing low/moderate income populations, single-parent household populations, and the <a href="URA's Market Analysis Map">URA's Market Analysis Map</a>. Committee members scored the remaining 60 points on more subjective measures according to prompts written and voted on by Committee members. NED scoresheet in Appendix D.

# **NED Allocation Meeting**

On July 1, 2021, nine of the fourteen NED Advisory Committee members met to determine the recommendation to City Council for the NED 2021 Regular grant and Capacity Building grant. The committee agreed to submit their recommendations to council based on the NED scoresheet they developed even though two committee members had not submitted scoresheets.

The NED Advisory Committee voted with seven in favor to recommend Manchester Citizens Council with the highest score for the one Capacity Building grant of \$50,000, which would be provided annually for four years. For regular NED funding, the Advisory Committee also recommended to fully fund the highest scoring applicants or applicants with average scores above 65 points and allocate the remaining \$101,500 for two \$35,000 awards and one \$31,500 award. # Opportunities to Improve Program

- Offer Capacity Building applicants a pre-application meeting to give feedback on proposed project. This would help applicants make the best case to the NED committee.
- Investigate reducing the staff salary and benefits amount for the Capacity Building grant to focus on organizations in more need.
- Add more non-City affiliated members to the NED Advisory Committee

# **2021 NED Program Updates Summary**

The Office of Management and Budget presents updates to the 2021 Neighborhood Economic Development (NED) grant program to address some concerns from NED Advisory Committee members.

#### Goals:

- Include more voices outside of City government to the Advisory Committee
- Provide a pathway for low capacity organizations to receive NED funding
- Maintain a pathway for organizations with proven results to access NED funding
- Make equity a major focus of the NED program

#### **Program Updates:**

NED program updates will be in the areas of equity and advisory committee participation.

#### Equity:

- Add service area need as a component in scoring
- Add a new capacity-building program
  - o Only for organizations spending below \$200,000 a year on salary/benefits
  - o \$50,000 committed for four years
  - o Required quarterly technical assistance meetings with City staff
  - o 2021 pilot with one multi-year grantee, and awarding an additional organization each following year
  - o Maximum of four organizations funded per year

#### Participation:

- Add two experts in community economic development to the NED Advisory Committee
- Flexibility in Council appointees--Councilmembers can appoint staff members, nonprofit leaders, academic experts, grantors from the foundation community, or other community members to represent the district on the NED Advisory Committee
- OMB provides Committee members with organization's budget information and summaries of applications

Neighborhood Economic Development (NED) grants provide operating support for organizations facilitating or developing housing and/or commercial development in CDBG-eligible areas of the City of Pittsburgh. Applicants can request up to \$40,000 grants for a one year term.

**New Capacity Building NED Grant:** For smaller organizations engaging in economic development in their communities. This grant is for organizations spending less than \$200,000 per year on staff salary and benefits. The organization awarded this grant will receive up to \$50,000 per year for four years as long as they meet program milestones. Awardees will also receive technical assistance to help grow the organization. Only one organization will receive this award. Applicants eligible for the Capacity Building grant will automatically be considered for regular NED grant as well, but will only be awarded the greater of the two—not both.

Funding is administered through the City of Pittsburgh Office of Management and Budget, Community Development Division (OMB-CD).

Please read all instructions and submit this application with attachments. **Grant** applications are due by Friday, May 14, 2021 at 5:00 p.m. No applications will be accepted after the deadline.

Applicants that have submitted eligible projects will be invited to make a presentation to the NED Advisory Committee in June. These presentations are followed by questions from Advisory Committee members. This year the presentations will be conducted online.

#### **SELECTION PROCESS**

The NED Advisory Committee consists of representatives from City Council, Department of City Planning, the Urban Redevelopment Authority, Mayor's Office and experts in economic development. This committee makes recommendations to City Councilmembers who makes the final determination on awards.

# I. Purpose of the meeting:

To determine the NED Advisory Committee's 2021 NED grant allocations (Capacity Building and Regular NED funds).

### **II.** Review of NED Scoring Process

The final scoring spreadsheet was reviewed. The scores were averaged and ranked based on submitted scores from NED Committee members. NED committee members were provided with multiple opportunities to provide their scores.

In some cases, NED Advisory Committee members recused themselves from scoring due to past relationships with participating organizations. The averaged final scores were not negatively affected by committee members not submitting scores.

There was a motion by Ray Garofalo to prevent absent committee members from submitting additional scores. Henry seconded the motion. It was approved by seven members.

# III. Capacity Building grant

Manchester Citizens Corporation (MCC) received the highest Capacity Building score (Mean Score of 66.88).

A discussion ensued concerning the second highest scoring applicant, Pittsburgh Hispanic Development Corporation (PHDC). The organization's application received a Mean Score of 65.52. Before the deadline to submit scores, OMB provided preliminary scoring data to the committee to answer a question posed by a committee member. After the last scores were submitted and included in calculations, the average score for PHDC moved down from what it was in the preliminary scoring data.

There was a motion by Dan Wood to approve MCC as the funded Capacity Building organization. Henry seconded the motion. The motion was approved by seven members.

This left a balance of \$450,000 for the regular NED grants.

#### IV. Regular NED grant

A discussion took place concerning the recent draft ARP funding allocations, and whether or not the potential funding should impact NED funding decision-making.

There was also discussion about whether or not Perry Hilltop and Fineview Citizens Council applications should be considered jointly, or individually.

Henry and Ray recommended that the organizations with a mean score of 65 or higher automatically receive the requested funding amount, up to \$40,000.

Organizations with a score below 65 would receive \$35,000, with the remaining balance of \$31,500 going to one organization. See attached table.

There was a motion by Dan Wood to approve the proposed NED funding outline. Henry seconded the motion. The motion was approved by seven members.

# V. Summary

Josh will send out a follow up email to gather input on the Capacity Building programming for the funded organization.

Ray mentioned the need to get more outside voices into the NED decision-making process, and for higher-capacity organizations to assist lower-capacity groups.
