RE:	Review and Recommendation of ITQ Contracts

A committee of technical experts from the Department of Innovation and Performance reviewed all responses submitted for Categories of Work that the Department may utilize for direct contracting. Each submission was evaluated on its technical merits, the strength of the staff proposed, and project examples provided by the proposer. While there were a number of highly qualified firms, the Department estimates that a limited number of contracts will be issued in the 2-year initial contract period. We have provided a recommendation as to the number of firms it would be prudent to have available in each Category of Work and the top ranked firms recommended by the Department committee in each Category of Work.
