Resolution further amending Resolution No. 654, effective October 25, 2001, entitled, "Resolution providing for an Agreement or Agreements, or use of existing Agreements and/or a Contract or Contracts, or use of existing Contracts, and for the purchase of materials, supplies, equipment, and/or services for various projects in connection with City Council's 2001 Neighborhood Needs Supplement Program; and providing for the payment of the costs thereof," by adding line item Lawrenceville Youth Group Equipment \$2,000.00 Council District 7.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and/or the Deputy Mayor, and/or the Director of the Department of General Services, and/or the Director of the Department of Engineering and Construction, and/or the Director of the Department of Public Works, and/or the Director of the Department of Parks and Recreation, and/or the Director of the Department of City Planning and/or the City Clerk are hereby authorized and directed to enter into a contract or contracts, or use existing contracts, and/or Agreement or Agreements or use existing Agreements for various projects in connection with City Council's 2001 Neighborhood Needs Supplement Program in an amount not to exceed <u>One Million Seventy Thousand Nine Hundred Seventy Three Dollars and Twenty-Six Cents</u> (\$1,007,973.26) One Million Five Thousand Nine Hundred Seventy Three Dollars and Twenty-Six Cents (\$1,005,973.26) chargeable to and payable from the following chart-fields.
