Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements with Auberle for services relating to Non-Congregate Shelter for the HOME-ARP program, for a total not to exceed of One Million Five-Hundred Thousand Dollars (\$1,500,000.00).
