Whereas, pursuant to the Redevelopment Proposal for the Greater Hill District Redevelopment Area approved November 15, 2016, and in the manner prescribed by the Urban Redevelopment Law, 35 P.S.§ 1701 et.seq., the Redevelopment Proposal for the Greater Hill District Redevelopment Area in the 5th Ward of the City of Pittsburgh was approved; and

Whereas, the Urban Redevelopment Authority of Pittsburgh has requested authorization to execute a Contract for Disposition by Sale of Land by and between the Urban Redevelopment Authority of Pittsburgh and the Hill Community Development Corporation, or an entity to be formed, in connection with the sale of Block 10-P, Lots 17 and 18, for \$15,000.00, said properties being in the 5th Ward of the City of Pittsburgh; and
