Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Acting Director of the Department of Innovation and Performance, on behalf of the City of Pittsburgh, are hereby authorized to enter into Agreement, Agreements or Amendments with Carahsoft Technology Corporation for the purpose of providing software services, training, and technical support relating to the Hootsuite Enterprise Social Relationship Platform, for city wide Social Media Management and Social Media Sentiment Analysis..

Section 2. Cost not to exceed One Hundred Four Thousand, Nine Hundred Fifty Dollars and Forty Five Cents (\$104,950.45) chargeable to and payable from the following JDE account:
