"Within the area bounded by 45th Street and Penn Avenue to the northeast, Cullen, Carroll and Howley Streets to the southeast, Main Street to the southwest and Government Way and Bruce Street to the northwest, including the southside of Penn Avenue from 45th Street to Cullen Street, Cullen Street from Penn Avenue to Carroll Street, Carroll Street from Cullen Street to Friendship Avenue, Howley Street from Friendship Avenue to Main Street, Milgate Street from Friendship Avenue to Main Street, Friendship Avenue from Woolslayer Way to Howley Street, Main Street from Howley Street to Saint Johns Way, Siebert Street from Main Street to 42nd Street, Geneva Street from Main

## IS HEREBY AMENDED TO READ:

Section 1. "Within the area bounded by 45th Street and Penn Avenue to the northeast, Cullen, Carroll and Howley Streets to the southeast, Main Street to the southwest and Government Way and Bruce Street to the northwest, including the southside of Penn Avenue from 45th Street to Cullen Street, Cullen Street from Penn Avenue to Carroll Street, Carroll Street from Cullen Street to Friendship Avenue, Howley Street from Friendship Avenue to Main Street, Milgate Street from Friendship Avenue to Main Street, Friendship Avenue from Woolslayer Way to Howley Street, Main Street from Howley Street to Saint Johns Way, Siebert Street from Main Street to 42nd Street, Geneva Street from Main Street to 44th Street, 42nd Street from Davison Street to Penn Avenue, Bruce Street from 42nd Street to 44th Street, Dunkheld Street from 42nd Street to 44th Street, Sherrod Street from 42nd Street to 45th Street, Post Street from 42nd Street to 44th Street, Calvin Street from 42nd Street to 44th Street, 44th Street from Davison Street to Penn Avenue, 45th Street from Davison Street to Garwood Way, and Garwood Way from 44th Street to 45th Street, Urbana Way from Government Way to Davison Street, School (Service) Way from the end of Area "A" to Davison Street, Percy Street from Davison Street to Bessemer Street, and Bessemer Street from 42nd Street to 44th Street, Penn Avenue from Cullen Street to Edmond Street, Torley Street from Friendship Avenue to Edmond Street, Pearl Street from Liberty Avenue to Penn Avenue, Liberty Avenue from Howley Street to Cedarville Street, Rosina Way from Ella Street to Pearl Street, Friendship Avenue from Pearl Street to Edmond Street, Orville Way (entire length), Sapling Way (entire length), Corday Way from Ella Street to Cedarville Street, Taylor Street from Liberty Avenue to Friendship Avenue, 232 and 234 Cedarville Street, 40<sup>th</sup> Street from Saint Johns Way to Arsenal Place, Almond Way from Davison Street to its terminus, Fisk Street from Saint Johns Way to Government Way, Davison Street from 43<sup>rd</sup> Street to 44<sup>th</sup> Street, 44th Street from Butler Street to Davison Street, Summit Street from 43rd Street to 44th Street, 46th Street from Davison Street to Bancroft Street, 39th Street from Butler Street to Penn Avenue and motorized vehicular parking shall be restricted to a one (1) hour time limit, between the hours of 7:00a.m. to 7:00 p.m., Monday through Saturday, except for vehicles displaying a valid Zone "A"residential or visitor's permit; and in addition 4124 Butler Street and 4122 Butler Street are eligible to purchase permits.
