Resolution authorizing a cooperation agreement or agreements, providing for the transfer of funds not to exceed Two Million One Hundred Fifty thousand (\$2,150,000) dollars to the City of Pittsburgh Equipment Leasing Authority for the purchase of vehicles, radios and equipment for use by the City of Pittsburgh Departments and Authorities.

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The Mayor and the Director of the Department of General Services, on behalf of the City of Pittsburgh, are hereby authorized to enter into a cooperation agreement or agreements, for the purchase of vehicles, radios and equipment for use by the City of Pittsburgh Departments and Authorities, in an amount not to exceed Two Million One Hundred Fifty thousand (\$2,150,000) dollars, chargeable to and payable from the
