Resolution amending Resolution No. 665 approved October 15, 2013, providing for the implementation of the Residential Parking Permit Program (RPPP) area "R" in the Bloomfield community (Council Districts #7) to expand the district to include additional addresses pursuant to Pittsburgh Code Chapter 549.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** Within the area bounded by: Fisk, from Penn to Howley; Canoe Way, from Clement Way to a point approximately 80 feet north of Cabinet Way; Cabinet Way, from 40<sup>th</sup> Street to Main; Howley, from 40<sup>th</sup> Street to Main; Clement Way, from Fisk to Main including only 4051, 4053, 4061, and 4069 Liberty; Mintwood, from 40<sup>th</sup> Street to Fisk; Mintwood, from 39<sup>th</sup> Street to Fisk; Ella, from Panama to end; Pearl, from Panama to end; Panama from Ella to Pearl; Idaline, from Ella to Pearl; Garnet, from Liberty to end; and Minerva, from Ella to Pearl; the south side of Penn, from 40<sup>th</sup> Street to Fisk; 40<sup>th</sup> Street, from Cabinet to Woolslayer.

**IS HEREBY AMENDED TO READ:**

**Section 1.** Within the area bounded by: 40<sup>th</sup> Street, from Cabinet Way to Woolslayer Way; Fisk Street, from Penn Avenue to Howley Street; Canoe Way, from Clement Way to a point approximately 80 feet north of Cabinet Way; Cabinet Way, from 40<sup>th</sup> Street to Main Street; Howley Street, from 40<sup>th</sup> Street to Main Street; Main Street, from Woolslayer Way to Liberty Avenue (even number addresses only); Penn Avenue, from 40<sup>th</sup> Street to ~~Fisk~~ 4058 Penn (even number addresses only); Woolslayer Way, from Fisk Street to Main Street; Clement Way, from Fisk to Main including only 4051, 4053, 4061, and 4069 Liberty; Mintwood Street, from 39<sup>th</sup> Street to Fisk Street; Ella Street, from Panama Way to Minerva Street; Orwell Way, from Panama Way to Minerva Street; Taylor Street, from Panama Street to its terminus; Sapphire Way, from Panama Way to Lorigan Street; Pearl Street, from Panama Way to Lorigan Street; Garnet Way, from Panama Way to its terminus; Panama Way, from Ella Street to Pearl Street; Idaline Street, from Ella Street to Pearl Street; and Minerva Street, from Ella Street to Pearl Street.
