Resolution authorizing the Mayor and the Director of the Departments of Public Works, Finance, and City Planning to enter into a revocable License Agreement or Agreements with GTECH Strategies to provide green-space improvements for up to six vacant City-owned sites as part of its ReClaim South Project.

**Be it resolved by the Council of the City of Pittsburgh as follows:**

**Section 1.** The Mayor and the Directors of the Departments of Public Works, Finance, and City Planning are authorized to enter into revocable License Agreement or Agreements with GTECH Strategies to provide green-space improvements for up to six vacant City-owned sites as part of its ReClaim South Project (the “Project”). Each License Agreement shall include a term of no longer than two (2) year(s), to be agreed upon by the parties.
