Resolution authorizing the Mayor and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, to enter into an Agreement or Agreements with PennDOT under which PennDOT will make improvements to and transfer Industrial Boulevard, approximately 1.2 miles of road, to the City, and the City will transfer to PennDOT, three current City street segments, those streets being: 1) Euclid Avenue from Baum Boulevard to Centre Avenue, approximately 350 feet; 2) Centre Avenue from Euclid Avenue to Highland Avenue, approximately 970 feet; and 3) Steuben Street, from point on Steuben Street identification Station point 139+77 to Cross Street, approximately 347 feet. In addition, Provost Road, from Weyman Road to Stewart

Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. Avenue, approximately 970 feet is to be paved by PennDOT and remain a City asset; the exchange of properties is mutually beneficial to the parties and will enable both the City and PennDOT to better manage and maintain their roadways.

The Mayor and the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are authorized to enter into an Agreement or Agreements with PennDOT under which PennDOT will transfer Industry Road; approximately 1.2 miles of road, to the City, and the City will transfer to PennDOT, three

current City street segments, those streets being: 1) Euclid Avenue from Baum Boulevard to Centre Avenue, approximately 970 feet; 2) Centre Avenue from Euclid Avenue to Highland Avenue, approximately 350 feet; and 3) Steuben Street, from point on Steuben Street identification Station point 139+77 to Cross Street, approximately 347 feet. In addition, Provost Road, from Weyman Road to Stewart Avenue, approximately 970 feet is to be paved by PennDOT and remain a City asset.
