The Mayor and/or the Director of the Department of Finance and/or the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby authorized to enter into agreements, in a form approved by the City Solicitor, providing for an up to \$1,000,000.00 grant from the U.S. Department of Transportation, up to \$490,000.00 in an RCAP grant through the URA, up to \$200,000.00 in DCNR grant monies, up to \$100,000.00 from the 2017 Trail Developments line item, Mon Wharf Switchback Design and Construction DELIVERABLE and up to \$\$492,616.00 in DCED Multi-Modal 2017 grant funds and \$1,506,643.00 from the Riverlife Task Force, for the construction of the "Mon Wharf Switchback Ramp".
