Resolution providing for the designation as a Historic Structure under Title 11 of the Code of Ordinances that certain structure known as the Hefty House, located at 624-626 East Ohio Street (24-N-118), in the East Allegheny Neighborhood, in the 23rd Ward, City of Pittsburgh. *(Public Hearing held 6/20/18)*

WHEREAS, the City of Pittsburgh has duly enacted Title 11of the Code of Ordinances, which protects and preserves Historic Structures, Districts, Sites, and Objects; and

WHEREAS, Nick Kyrazi has nominated the Hefty House at 624-626 East Ohio Street (24-N-118) for designation as a Historic Structure; and

WHEREAS, the Historic Review Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the Historic Review Commission vote to recommend that City Council designate the Hefty House located at 624-626 East Ohio Street (24-N-118) as a Historic Structure resulted in a deemed denial; and

WHEREAS, the City Planning Commission has held a public hearing to gather testimony from the property

owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the City Planning Commission has voted to recommend that City Council designate the Hefty House at 624-626 East Ohio Street (24-N-118) as a Historic Structure; and

WHEREAS, the Council of the City of Pittsburgh has held a public hearing to gather testimony from the public concerning the appropriateness of this designation; and

WHEREAS, the Council of the City of Pittsburgh finds that the aforementioned Hefty House is a Historic Structure that should be preserved;

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PITTSBURGH AS FOLLOWS:

Section 1. Pursuant to the provisions of Title 11 of the Code of Ordinances, the Council of the City of Pittsburgh hereby designates as a Historic Structure the Hefty House located at 624-626 East Ohio Street (24-N -118), in the East Allegheny Neighborhood, in the 23rd Ward, City of Pittsburgh.
