Resolution amending Resolution 209 of 2022, which authorized the Mayor and the Director of the Office of Management and Budget to enter into an Agreement or Agreements with Pittsburgh Futures for professional services relating to leadership development training, by increasing the authorized spend by Ninety Thousand Dollars (\$90,000.00) for a new total not to exceed cost of One Hundred Seventeen Thousand Three Hundred Thirty-Six Dollars (\$117,336.00).

Be it resolved by the Council of the City of Pittsburgh as follows:

Resolution 209 of 2022, entitled “Resolution authorizing the Mayor and the Director of the Office of Management and Budget to enter into an Agreement or Agreements with Pittsburgh Futures for professional services relating to leadership development training at a sum not to Twenty-Seven Thousand Three Hundred Thirty-Six Dollars (\$27,336.00) and for the payment of the costs thereof,” is hereby amended as follows:

Section 1. The Mayor and the Director of the Office of Management and Budget, on behalf of the City of Pittsburgh, are hereby authorized to enter into an Agreement or Agreements with Pittsburgh Futures for professional services relating to leadership development training at a sum not to ~~exceed Twenty-Seven Thousand Three Hundred Thirty-Six Dollars (\$27,336.00)~~ **One Hundred Seventeen Thousand Three Hundred Thirty-Six Dollars (\$117,336.00)**.

Funds shall be paid from the following grant **and general fund** accounts:

\$27,336.00 from 0229400385.53901.00

\$90,000.00 from 11101.102200.53901.2023

Section 2. Said Agreement or Agreements shall be approved by the City Solicitor as to form.
