### Section 1.

The Mayor and/or the Director of the Department of Finance and/or the Director of the Department of Public

Works, on behalf of the City of Pittsburgh, are hereby authorized to enter into agreements in a form approved by the City Solicitor, providing for an up to \$750,000.00 grant from the U.S. Department of Transportation, up to \$490,000.00 in an RCAP grant through the URA, and \$1,251,244 from the Riverlife Task Force for the construction the "Mon Wharf Switchback Ramp."

Grant funds shall be deposited to the following accounts:

The Mayor and/or the Director of the Department of Finance and/or the Director of the Department of Public Works, on behalf of the City of Pittsburgh, are hereby further authorized to enter into agreement or agreements, contract or contracts, and to make all legitimate expenditures required under the terms and conditions of the Grant Agreement with the Commonwealth of Pennsylvania Department of Transportation and with various forprofit corporations and non-profit agencies providing outlined in Section 1 of this resolution. Said agreement or agreements, contract or contracts, or expenditures shall not exceed Two Million Four Hundred Ninety-One Thousand and Two Hundred Forty-Four Dollars (\$2,491,244.00) chargeable to and payable from:
