Title: Resolution further amending and supplementing Resolution No. 180, effective April 5, 2000, entitled "Providing for an Agreement or Agreements, or use of existing Agreements and/or a Contract or Contracts, or use of existing Contracts, and for the purchase of materials, supplies, equipment, and/or services for various projects in connection with the Neighborhood Needs Program in Council District 3; and providing for the payment of the costs thereof," by deleting the line item "Infrastructure Painting" \$25,000 and reducing the line item "Projects-Allentown/Beltzhoover/ Knoxville" by \$28,250, and by adding \$18,000 to "Amanda Street Steps", and adding \$10,000 to "Refurbish Quarry Field-Reseed for Football and Soccer only" and by creating new line items "Allentown Business Association - Grandview Park Cameras" \$5,000, "McKinley Park Little League Field Improvements" \$5,000 and "Curb and Sidewalk Repairs-Oakland" \$5,250. Total cost of all projects is not to exceed \$960,000.
