Section 1. The Mayor and the Director of the Department of Mobility and Infrastructure, on behalf of the

City of Pittsburgh, are hereby authorized to execute relevant agreements with PennDot to set terms and conditions for the construction by PennDOT of certain supplemental improvements on East Carson Street, with certain contributions to be made by the City <u>at an amount not to exceed eight hundred eighty-six thousand one-hundred and sixty-two dollars and ninety-nine cents (\$886,162.99)</u> [through separate legislative appropriation in a subsequent year].
