Resolution adopting Plan Revision to the City of Pittsburgh's Official Sewage Facilities Plan for the Garden Theater Block Project, 23-L-76 and 23-L-83, in the $22^{\text {nd }}$ Ward, Pittsburgh, Pennsylvania 15233.

WHEREAS, SECTION 5 of the Act of January 24, 1966, P.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act," as amended, and the rules and regulations of the Pennsylvania Department of Environmental Protection (the "Department") adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, requires the City of Pittsburgh to adopt an Official Sewage Facilities Plan (the "Official Plan") providing for sewage services adequate to prevent contamination of waters of the Commonwealth and/or environmental health hazards from sewage wastes, and to revise said plan whenever it is necessary to determine whether a proposed method of sewage disposal for a new development conforms to a comprehensive program of pollution control and water quality management; and

WHEREAS, Garden Theater Block LLC proposes to develop approximately 0.66 acres of land in the City of Pittsburgh's Central Northside neighborhood, 22nd Ward, Allegheny County. The properties to be developed are located in a block surrounded by Eloise Street to the north, Federal Street to the east, West North Avenue to the south, and Reddour Street to the west. Included in this area are the Garden Theater Building, the Morton House, and several other buildings that have recently been razed. The parcels identified in the Allegheny County system as Block and Lots 23-L-76 and 23-L-83 and described in the attached Sewage Facilities Planning Module (the "Planning Module") for land development, proposes that the project be served by use of existing connections to the City of Pittsburgh sewage systems; and

WHEREAS, the Pittsburgh Water Sewer Authority, the Allegheny County Sanitary Authority, the City of Pittsburgh Planning Department and the Allegheny County Health Department have reviewed the respective components of the attached Planning Module in regard to each authority/department's expertise and have approved the respective components as explained in the attached Planning Module.

WHEREAS, based upon the approval of the above authorities and departments, the City of Pittsburgh finds that the project described in the attached Planning Module for land development conforms to applicable zoning, subdivision, other municipal ordinances and plans, and to a comprehensive program of pollution control and water quality management.

## Be it resolved by the Council of the City of Pittsburgh as follows:

Section 1. The City of Pittsburgh hereby adopts a Plan Revision to the City of Pittsburgh's Official Sewage Facilities Plan, the above-referenced Planning Module for land development, which is attached hereto as

Said Planning Module includes the proposed identified Garden Theater Block LLC has proposed the development of certain parcels of land identified as parcels 23-L-76 and 23-L-83, in the $22^{\text {nd }}$ Ward of the City of Pittsburgh, Allegheny County, Pennsylvania.
