Resolution providing for the designation as a Historic Structure under Title 11 of the Code of Ordinances that certain site known as Catahecassa Spring (on East Circuit Road in Schenley Park), block and lot number 27-S-150-0-1, in the 14<sup>th</sup> Ward, City of Pittsburgh. WHEREAS, the City of Pittsburgh has duly enacted Title 11of the Code of Ordinances, which protects and preserves Historic Structures, Districts, Sites, and Objects; and

WHEREAS, Matthew Falcone has nominated Catahecassa Spring (on East Circuit Road in Schenley Park) for designation as a Historic Site; and

WHEREAS, the Historic Review Commission has held a public hearing to gather testimony from the property owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the Historic Review Commission has voted to recommend that City Council DESIGNATE the Catahecassa Spring (on East Circuit Road in Schenley Park) as a Historic Site; and

WHEREAS, the City Planning Commission has held a public hearing to gather testimony from the property

owner and other interested parties concerning the appropriateness of this designation; and

WHEREAS, the City Planning Commission has voted to recommend that City Council DESIGNATE Catahecassa Spring (on East Circuit Road in Schenley Park) as a Historic Site; and

WHEREAS, the Council of the City of Pittsburgh has held a public hearing to gather testimony from the public concerning the appropriateness of this designation; and

WHEREAS, the Council of the City of Pittsburgh finds that the aforementioned site is a Historic Site that should be preserved;

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** Pursuant to the provisions of Title 11 of the Code of Ordinances, the Council of the City of Pittsburgh hereby designates as a Historic Structure the building known as the Catahecassa Spring on East Circuit Road in Schenley Park, block and lot number 27-S-150-0-1, in the 14<sup>th</sup> Ward, City of Pittsburgh.
