Resolution amending Resolution No. 819, approved December 16, 1997 entitled "Amending Resolution No. 934 approved September 18, 1992 entitled providing for implementation of a Residential Parking Permit Program (RPPP) Area T in the Beechview community pursuant to Pittsburgh Code Chapter 549" so as to amend the streets included in Area "T".

## Be it resolved by the Council of the City of Pittsburgh as follows:

**Section 1.** The first paragraph of Section 1 of Resolution No. 819 approved December 16, 1997, which paragraph provides for the street to be included in Area "T" and which presently reads as follows:

Within the area bounded by: Broadway Avenue, from Fallowfield Avenue to Neeld Avenue; Beechview Avenue, from Sebring Avenue to Broadway Avenue; Fallowfield Avenue, from Sebring Avenue to Tonapah Avenue; Belasco Avenue, from Broadway Avenue to Crosby Avenue; Pauline Avenue, from Broadway Avenue to Catalpa Street; Shiras Avenue, from Broadway Avenue to Los Angeles Avenue; Neeld Avenue, from Broadway Avenue to Los Angeles Avenue; and Freemont Place, from Neeld Avenue to Mackinaw Avenue.

is hereby amended to read as follows;
